Dear Friends,



Kay Reebel was an accomplished woman with a distinguished career at the University of Michigan School of Social Work. She was a very active member of First Presbyterian Church, serving in numerous leadership roles. She had keen interests in several ministries, including children, youth, campus, and resident ministers. Our Church was blessed with a gift from Kay of about \$500,000 in 2011. While her gift was undesignated, selected members of the Endowment and Special Gifts Committee and First Presbyterian Staff met with close friends of Kay's who had known her, as she had no family at the time of her death. In the spirit of



how Kay would have wanted her gift to be used, a majority of the gift (95%) has been designated to support the Resident Ministry Program and is a significant step toward endowing that Program so that it will be self-funding in the future. The remaining portion (5%) will support our weekly Radio Ministry which enabled Kay and others to worship with us each week. Kay's service and gift to our Church are legacies to celebrate and will live on for generations to come.

Kay Reebel, In Memoriam (2012)

Our family wished to make a gift to First Presbyterian Church in memory of our parents without too many strings attached. Ideally we would like it to go toward an updated plan for the church grounds. We feel that preserving and continuing to improve the church property with all its inherent beauty, will provide enduring value to the church and would be consistent with our parents' interests and values. We are hoping this gift will be helpful in creating a meaningful plan that can guide church grounds maintenance and improvements now and in the future.

How Will my Gift be Used?

Your gift will be used exactly as you request – either a gift that you designate for a specific purpose(s) or one that is undesignated and would support a variety of needs of the Church. Throughout our first 185 years, First Presbyterian Church of Ann Arbor has received many gifts, large and small. These generous gifts have helped to support vibrant and meaningful worship and music; ministries targeted for youth, campus, and mature members; heartfelt pastoral care; a model Resident Ministry Program; and local, national and international mission outreach. Additionally, bequests and special gifts can help sustain our historic Sanctuary and facilities and can help fund new and innovative outreach opportunities that expand the ministries of our church.

How do I Become a “Legacy Partner” and Make a Planned Gift?

The process to make a gift to First Presbyterian Church is simple and straightforward. The most common way to designate or make a gift is to include First Presbyterian in your will with a bequest. The following is a sample bequest. “I give \$_____ (or ___ % of my estate) to First Presbyterian Church, Ann Arbor, Michigan, for its General Endowment Fund (or state a specific use).”
